Dear Mr. Woods:

It is a source of considerable gratification to my Government that the formalities relating to the renewal of Indonesia's membership in the IBRD have now been completed. We are looking forward to receive the guidance and cooperation of the IBRD in our program for the rehabilitation of the Indonesian economy.

We already have reason to be grateful to your organization for sending last fall the mission headed by Mr. McIvor, to examine the urgent import requirements of the economy. We are appreciative also of the highly constructive participation of Mr. Cargill and Mr. McIvor in the meeting at Amsterdam in February last. As you are well aware from the discussions at that meeting, our current efforts, of which our renewal of membership in the IBRD is one facet, are centered on a stabilization and rehabilitation program designed to overcome the economic deterioration which the country is now facing. This program includes the introduction of a more realistic trade and exchange system, the achievement of fiscal balance, strict credit control, the elimination of direct controls and of subsidies responsible for price distortion, and reliance upon the market mechanism,

There are recent encouraging indications of success of the stabilization measures, which are and must continue to be the first priority for restoring financial order and establishing confidence in the currency and in the prospects

of the economy. On the other hand, we must at the same time turn our attention increasingly to the rehabilitation of productive capacity and infrastructural conditions, on which the revival and expansion of economic activity ultimately depend. It is our hope that the IBRD will assist us in this task.

In the short run, we have assumed that as a prerequisite to the consideration of any IBRD assistance you may wish to send a mission to study our economic performance and prospects. We would of course welcome such a mission as soon as it could be despatched. From our side, the report of such a mission, if it could be available well before the end of the year, would be invaluable to us in preparing our 1968 budget and deciding the allocation of resources among and within sectors.

In that connection, and with reference also to the longer run task of drawing up the rehabilitation requirements of the economy, we would like to discuss with you the possibility that any IBRD economic mission might include some sector specialists who would be able to indentify and make recommendations on sectors, programs and projects requiring further studies for proper determination of our needs. Such specialists would be most welcome to stay longer than the typical economic mission, so as to give some guidance to Ministries and agencies; we would be receptive also to their suggestions regarding economic policies both overall and in various fields. It is, indeed, our ultimate hope that the IBRD would consider assisting us in coordinating the provision of urgently needed technical assistance from various sources, including members of the Inter-Governmental Group; and also assisting us in drawing up as soon as possible a thorough-going rehabilitation program for the Indonesian economy.

We look forward to hearing from you.
